Government Contractors and the False Claims Act

The False Claims Act (FCA) is a federal law that imposes liability on persons and companies—typically federal contractors—who knowingly submit "false claims" for payment to the government, or fail to reimburse the government for an overpayment received. The FCA includes a qui tam provision that allows "whistleblowers" to file civil actions on behalf of the government and recover large awards from the target company. FCA allegations can also lead to federal criminal investigations. Whistleblowers are often employed by the company accused of wrongdoing in the qui tam action and provide the government with significant information about the company's operations, management, and alleged fraudulent scheme. The presentation will highlight recent trends in FCA actions, provide practical information about, and strategies for, dealing with FCA actions, and discuss operational compliance programs to mitigate exposure to whistleblowers' claims and FCA allegations

Contaminated Lands Transferred to Alaska Native Corporations Under ANCSA

The Bureau of Land Management recently delivered a report to congress which provided the most comprehensive inventory to date of known contaminated sites on lands conveyed to Native Corporations through the Alaska Native Claims Settlement Act (ANCSA). These conveyed contaminated sites raise many human health and safety, environmental, and economic concerns for communities throughout Alaska. This session will discuss the current status of ANCSA contaminated sites, plans to resolve this statewide issue, and the tools available to address these sites — including brownfields resources available through the Alaska Department of Environmental Conservation and the Environmental Protection Agency that may be able to assist with eligible sites not already enrolled in a cleanup plan.

Cloud-Based Shareholder Records Management Software

Description: Maintaining accurate shareholder records is a critical function of any corporation, including ANCs. Accurate records enable corporations to effectively communicate with their shareholders and to generate accurate lists for the purpose of issuing shareholder distributions and tax forms and administering corporate elections. There are a number of software solutions on the market to assist corporations with managing not only these items, but other aspects of shareholder records management as well, such as stock transfers, payment and certificate tracking and withholdings. The newest of these - cloud-based software – is quickly becoming a favorite, because it eliminates the need to purchase expensive servers and hire IT staff for maintenance, and instead requires only an internet connection. Additionally, cloud-based software allows users to access the database from multiple locations, including at different office locations or when offsite conducting shareholder events. If you maintain or administer shareholder records, this session is for you.
